Apostille is a validation stamp ensuring that a particular document is recognized in certain foreign countries (countries signatory to the 'Hague Convention of 5 October 1961 Abolishing the Requirement of Legalization for Foreign Public Documents.' Denmark and the United States are both signatory countries to this Convention.) Apostille (certifications) do not require further legalization by the U.S. Embassy in order to be legally enforceable in the United States.
